- Councillor Garwood confirmed that the motion regarding use of the Township's Community Hall Parking lot for bike night and the Farmers' Market was approved by Council, unanimously.
- Press release was issued noting the BIA will be hosting the Market this season, and shared on the front page of the Springwater News.
- Councillor Garwood has met with George College about the hiring a coop student to facilitate the Market planning and organization.

CEO Delgado confirmed that the Library would like to continue participation in the Market.

Next month the Board will look to confirm vendor fees, and subsequently proceeding with the call for vendors.

6.1. New Businesses & Local Business Update

CAO Delgado provided an update on the Springwater Library, noting in summary:

- A new program guide is available;
- 100,000 + items were checked out in 2023; and,
- In the process of initiating the development of a new Strategic Plan.

Additionally, CAO Delgado noted that the Library, and ultimately the BIA, would benefit from the purchase of an OWL speaker to enhance virtual/hybrid meeting formats. CAO Delgado will bring back information on the purchase of an OWL and see if the BIA Board would be willing to contribute in part.

6.3 Financial Update

No update was provided. Requested through Staff Liaison Belcourt a copy of the approved 2024 budget, with year-to-date expenses.

6.4 Marketing Update

Member Stanley provided an update on the BIAs marketing efforts highlighting that the BIA continues to post regularly on social meeting, and as a result the social reach of the accounts are growing.

Member Stanley also presented the idea of purchasing generic BIA branded banners for the main street to be installed in the "in-between seasons" when flowers or other banners are not present. Banners cost roughly \$175 - \$200 a piece. The BIA Board entertained the idea but ultimately decided to hold off for now.
