### 5.3 Updated By-Laws

Renee presents a quick overview of the updated by-laws. Highlighted items:

- There will be the available for space on the BIA for Associate memberships: non-voting persons representing other local businesses that do not qualify for the the Catchment Area. The fee for this will be decide upon at the AGM.
- It is imperative that we reach out to the Township in the event the Board requires a 'closed' session to make sure it is arranged appropriately.
- Proxy votes are NOT allowed under the By-laws. Those not in attendance/virtual attendance for the meeting will not be counted.
- Council Members are allowed to sit on the Board.
- Duties outlined for Township Liaison.

The updated by-laws will continuewhen the new deputy clerk is selected; aiming for the fall of 2021. In the meantime, Renee will send the new draft by-law for the Board Members to review.

Kimberley requests that the By-Laws include a table of contents for easy reference.

#### 5.4 Removal from Board Membership

### 6. <u>Updates from Council</u>

The OPP servicing board are formatting a new committee consisting of 12 members (2 municipality, and one member at large) to help implement new broad band services to improve Springwater digital connectivity.

The Springwater – Elmvale's Farmer's Market opens June 18<sup>th</sup>, through to September 2<sup>nd</sup> 2021. The Market will continue to run every Friday from 9 am – 2 pm. Masks are mandatory.

New floral baskets to be hung along the main street in Elmvale this coming week.

Virtual job fair, coming up June 2nd 2021 between 10 a.m. & 2 p.m. for local businesses and job seekers, simcoe county.ca website. Currently, one local business is registered as an employer.

Ask the expert series continues on June 9th 10:00 a.m.. This session focuses on women in business and COVID 19 impacts on women in business.

The Township is looking for partnership opportunities and new ideas for a mural on the west wall of the Knox Building (community hall) focusing on the history of Springwater. We want to make it INSTAGRAM worthy! The idea was well received by the members and it was noted the BIA would be interested in further discussing opportunities for partnership in the future.
